- ii. MOA for Region and National level is still under review nationally
- iii. NRCS is operating under continuing resolution to December 7 though they have a partial allocation for after that date; EQIP reduced overall but want to keep \$500,000 available under EQIP for Tribes for use in several rounds of funding until used; Chris and Melissa to discuss more later
- iv. NRCS has had a lot of staffing/hiring in last FY, filling 40 positions across the State; there is a couple of additional hiring activities going on this year
- v. Pathway Program applications are being evaluated right now for the summer of 2021; if not all positions filled, then there will be another round of hiring in January; good candidates are in the review process
- vi. USDA did get approval for Farm Production, and Conservation Area Program (NRCS, FSA, and Risk Management) will be hiring folks for these positions with this program (17 positions in WI); hiring might be done by direct hire; focus will be on soil conservationist; appreciate our assistance on getting the word out on vacancies
 - 1. Jerry asked where he can find information about the positions? Angela doesn't have them yet, expect it to happen in December and will share it then; asks that if we have someone who would be interested in sharing their contact information with her, MElissa, or Chris before then

- South Carolina, Deregulated pine shoot beetles and emerald ash borer; EAB biocontrol, spotted lanternfly
- 3. Routine PPQ WI surveys in 2020: Asian Gypsy Moth (AGM) is a new concern that spreads more rapidly. Usually, the source is foreign shipping vessels, and there are several ports in WI where they do trapping to detect possible occurrences, negative so far, determine the difference from European Gypsy Moth is determined via DNA; Cerceris biosurveillance (native predatory wasp) is done by citizen science volunteers, wasp goes after metallic boring beetles like EAB and other non-natives so they find wasp nests to survey for different species of concerns they might be eating, most work in Stevens Point but looking for more volunteers throughout the State; velvet longhorn beetles that were found in furniture in 5 sites in 2016 but all areas are negative in 2020 when surveilled with very effective new lure developed; Khapra beetle is a stored grain pest that devastates grain in other parts of the world-don't have it in the US yet but keeping an eye out for it at organic soybeans and corn sites that are imported from counties with known sources
- 4. Unsolicited foreign seed packets were received throughout WI, and packages contained different varieties of seeds, citizens turned them into Madison PPQ office, seeds received in June/July, DATCP created an online reporting site and news media picked up the story; investigated whether they concerned any seeds of concerns, most common varieties of fruits and vegetables and flowers, but there were a few of noxious weeds and had some had a beetle; they worked with Amazon and Customs to shut down seed sales platform, still getting some seed packets now
- 5. Tomato brown rudose fruit virus detected post of entry but not found in WI; some tomatoes go to Canada from Mexico and then trucked into the US; increase inspection and certification of testing; sampled seedlings producers in WI for peppers and tomatoes and there were no detections in WI

- 6. Ralstonia is a concern because the disease could be widespread and devastating; it was found at a major production facility, and all customers were contacted, and the disease was eradicated from 25 greenhouses in WI
- 7. Asian Longhorn Beetle long time since detected in the US, but new detection in South Carolina port city; homeowner reported it and 58.6 miles quarantine, 3000 trees to be removed, usually can eradicate it; only infestations left in OH, NJ, and SC
- 8. The deregulated pine shoot beetle was federally deregulated in October, but several states continue to regulate it. There hasn't been much of an economic impact from this as they expected; EAB deregulation is almost done, but management will continue, WDNR is continuing to release biocontrol wasps; looking for more sites for EAB biocontrol, so contact Chris Deegan if there are sites that could be used
- 9. Spotted lanternfly eradication program the APHIS is providing funding for; not found in WI yet, but lay eggs on anything (rail cars, campers, etc.) which can move it great distances
- 10. Cooperative Agreement Funding provided in FY19 \$800K total, FY20 \$835K total, FY21 \$1.4M total; WTCAC has gotten a lot of this funding over the years in either pest survey and detection category or the outreach and capacity building category
- 11. APHIS-Tribal Capacity Building working on increasing this work and the focus on emergency response planning and ag pest/disease response MOUs; planning training for 2021 in late summer and early fall and may be available virtually
 - a. Jerry shares that they put together a draft 1-page questionnaire on emergency response workshop; would like tribal feedback on this form; Jerry wants to send it out for feedback before December 1
- 12. Spotted-wing Drosophila biocontrol proposal want to release parasitic wasp to control this fruit fly which is a crop pest; sent letters to Tribal governments within the last

Eric: There was a tribal leader letter that went out on 11/9/20 for CRP1 appropriations, and there was an exception proportionment for this year; TPA programs should get the full dollar amount for FY21 that they got in FY20, which means one allocation to Tribe, but once a final FY21 budget is passed then funding might get a rescission request
 - ii. Albany: There will be a December 2 GLRI Tribal Forum hosted by BIA & EPA, including BIA PRogram update on Distinct TRibal PRogram and finalization of the framework; there will also be select tribal presentations on GLRI projects; GLRI RFP should go out in early December with a deadline in mid-February; RFP for other Wildlife and Parks went out in late October with a deadline in January; the deadline for Noxious Weed funding is 12/16

- iv. IAC hired Colby Duren from the IFAI and formerly NCAI as our policy director who will be based in DC to lead advocacy efforts on the Farm Bill and other efforts

 - ii. Federal Trust Responsibilities are taking very seriously by USDA.

They are also working with WICCI and brainstorming potential ways to adapt. They have a companion Northern WI document.

- u. WI Department of Natural Resources (WDNR) Shelley Allness
 - i. They are heading into State Deer hunting season, collecting CWD samples. The emphasis this year is going to be Northern and North East Wisconsin this year. Offering assistance to the Tribes. Kiosks and dumpsters are available
 - ii. Enbridge reroutes proposal the agency is working on EIA. Work is ongoing, and they do have a hired consulting assisting with that EIS development. Trying to hold them every other month but will be having them more often.
 - iii. Summer Tribal Youth Program a message was just recently sent out by Shelley. We are all seeing some economic effects, and the State is not excluded from this. Still able to offer the grant, but it will be about \$4000 less for each award this year. We won't know for another year if we need to keep that reduced amount or not. It is still a good chunk of money, and there has been alot of success with the program. New grant administrator Chrissy Kosak, Beth is retiring this week.
 - iv. Mining Review of draft mining proposal is ongoing. Many Tribes are participating in the review process. Larry Lynch is leading the process. Thank you for all the comments submitted so far. These are not easy statutes or rules to review, and we appreciate the

- input. These will head to Natural Resource Board in December. Larry will continue to provide legislative updates. Will there be a response to the comments submitted. Shelley is going to check with Larry on that.
- v. The State is working on updating the Walleye management plan. Encourage consultation this. GLIFWC is actively involved in this process. Shelley will send milestone updates.
- Wolf delisting big topic, but the State does no know a whole lot vi. yet. State ha management authority starting January 4. They are reviewing the delisting proposal right now and will be presenting it to the Governor's office. Once the State takes over management authority, that will allow the State to work with farmers again on depredation issues. The State will issue farmers permits to protect livestock and also work with landowners on abatement measures. Are unsure if there will be a hunting season. State law says that the State is required to have a hunting season. Starting the first Saturday in November, the State will have a harvest season. They are unsure if the season will begin in January or wait until November of 2021. There is a long way to go in a short time frame on all of this, and shelly will continue to keep everyone updated. Hopefully, this will open the door for how the Tribes have a voice on wolf management in the State. They are also discussing the restructuring of the wolf advisory committee. This is a high priority for the administration right now.
- v. Wisconsin Lakes Partnerships (WLP) Pat Goggin sent the Lake Tides newsletter to Jeff to distribute. This will get included with the minutes. He was still working on pulling together Wisconsin Water Week that was mentioned at the last meeting. He will be in contact with WTCAC staff to participate in the Wednesday event. A new project with Lake Nicaragua. He will have more information about what this will look like at the December meeting.
- w. USDA Christopher Ester, Stream Crossings and Inventory Provided a briefer presentation that was also provided to the WTCAC
