USDA APHIS ERP Training Agenda

Goal of the Training: To develop an understanding of Animal & Plant Health Inspection Service (APHIS) Line Programs to address the need to develop Emergency Response Plans (ERP) and Memorandum of Understanding (MOU).

Objective of the Training: By the end of the training, participants have gain awareness on the need to place and develop a Tribal Animal and or Plant Health ERP or MOU for cooperative relationship with APHIS.

<u>Audience</u>: Tribal Council / Officials, Natural Resource Managers & Staff, & Invasive Species program staff, and Response Teams.

The training will address APHIS' Emergency Management Plans awareness by:

- Explaining APHIS Line Programs Detection and Surveillance Programs tie to Emergency Response Plans or Memorandum of Understand (MOU).
- Demonstrating in identifying "Risk Pathways" may be responsible for pest and disease introduction.
- Discussing mitigation measures if/when pest and disease is detected.
- Identifying how Federal are working in cooperative partnership with State for animal or plant health emergency response.
- Explaining the use incident command system (ICS) in emergency response.
- Showing Tribal Nations how ERP and MOU are to be use as a benefit on tribal lands.
- Demonstrating in taking steps in developing an ERP and or MOU.
- Soliciting Tribal input as how ERP and or MOU could be adaptable within Tribal Nations' emergency plans.
